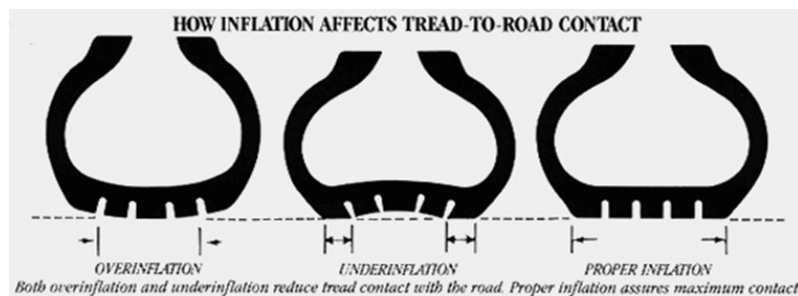

Safe driving over the holidays

Embarking upon a driving holiday? Don't forget to check your tyre pressure!

The air in your tyres carries the total load of your vehicle and passengers, so correct inflation pressure is essential to ensure the integrity of tyres and the safe handling of your motor vehicle.

The pressure of your tyres should be checked regularly, and when they're cold. Pressure should be checked on a weekly basis and most certainly before commencing any long distance travel. Remember to check the tyre placard for recommended inflation pressures. Under inflation will cause excessive flexing in the tyre and weaken the casing, and it will cause rapid shoulder and irregular tread wear. Over inflation reduces the ability of the tyre to absorb road shocks and will cause excessive wear to the centre of the tyre.



Heavy loads or towing puts an extra strain on your tyres. If your vehicle is fully loaded with passengers and luggage, the general rule is to add 28kpa (4PSI or 4lbs).

Believe it or not, tyre pressure can have a big impact on our environment! An under-inflated tyre creates more rolling resistance and therefore more fuel consumption. By keeping your tyres inflated to their proper levels, you can help maximise your car's fuel economy and minimise the impact on our environment.

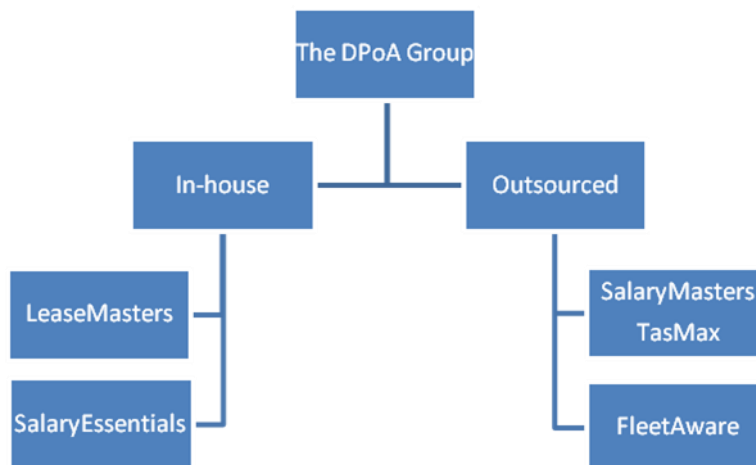
